# JARL TOKYO Registered Clubs' Activity Enhancement

# **Campaign in October (Report)**

JARL TOKYO Registered Clubs' Activity Enhancement Campaign in October was held again this time, and KCJ also participated this year again. I would like to report the summary.


- 1 What's this event?
- JARL, Japan Amateur Radio League stipulated Tokyo's prefecture number as "10."
   In honor of this number 10, JARL Tokyo Branch called on the registered clubs "Let's make October the PR month" and started this project in 2019.
- JARL Tokyo Branch makes a special common QSL card and provides registered clubs with it according to their activities during October.
- 2 The common special QSL card (Original design by JH1ASG)



 This year's design is Ariake Gym-ex, the new venue of JARL Ham Fair in 2024 and 2025. Gymnastics events were held there during the 2020 Tokyo Olympics, and

- boccia events were held during the Paralympics.
- As a member, I confirmed with the brand management department of the Tokyo Organising Committee of the Olympic and Paralympic Games that the phrase "Host City of Olympics and Paralympics Tokyo 2020 & 1964" can be used as a statement of fact.
- The data side was left blank, and the display of the club name, club callsign, etc., was left up to each registered club.

#### **REMARKS**

- \* Including JARL Tokyo Branch
- \*\* Based on the number of QSOs in October by each club. As several QSO data may be printed in a single card, the number of QSL Card is not the number of QSOs.
- \*\*\* Including the number of QSL card issued by a club which printed their own QSL for this campaign in 2024.
- In 2024, the number of special common QSL card prepared by JARL Tokyo branch was 15,000, the highest ever. The number of participating clubs was 19, including JARL Tokyo Branch.
- When I actually listened to the QSOs and read the SNS X (formerly Twitter), I realized that it is becoming an annual event for JARL Tokyo branch. When

announcing "Tokyo 10," some clubs enjoyed the pileups.

• I would like to appreciate the participating clubs for their participation in this very successful event.

#### 5 Hope for the future

- Despite the coronavirus pandemic, it is an undeniable fact that the Tokyo 2020 Olympic and Paralympic Games were held mainly in Tokyo in 2021.
- By continuing to hold this event and issuing the special common QSL cards, I hope to continue the legacy of the Games, that is, to pass on Tokyo, the host city of the 1964 and 2020 Olympic and Paralympic Games, to future generations.

After this campaign, Mr. Kurakichi Sawada JG1NKJ, Branch Manager of JARL Tokyo sent a thank-you email to KCJ. He promises that JARL Tokyo will hold this event in 2025. I am looking forward to KCJ's attendance.

# Revision of KCJ Bylaws

#### [JH1ASG/NAKA]

Following the revision of Articles of KCJ, we revised the Bylaws of KCJ.

The main points are as follows:

## Bylaw 9 Admission Fees and Membership Fees: Completely revised.

# [Previous Bylaw]

A member shall pay his/her membership fee defined in Article 7(1) in a lump in advance of beginning of a fiscal term.

- (1) The fee shall be paid to the Club account.
- (2) One fiscal term contains two years. The payment of fee must be made by the end of June in the first year of a fiscal term.
- (3) A new Japanese member shall pay ¥600 as an entrance fee and does not need to pay a membership fee for the first fiscal term. A new associate member must pay US\$5 as an entrance fee. In case of foreign currency, cash or electronic remittance, such as PayPal are acceptable.
- (4) Once it is paid, it will not be returned. (When a member who paid a membership fee becomes silent key before the beginning of the new fiscal term, the fee paid shall be returned.)

# **Revised Bylaw**

The admission fees and membership fees stipulated in Article 8 are as follows:

- (1) The admission fee is 600 yen (US\$5 for Associate Members).
- (2) The membership fee per fiscal year is 1,200 yen. However, this fee is waived for Associate Members.
- (3) The admission fee and membership fee shall be paid in advance in one lump sum and transferred to the account designated by the Club. The members shall bear transfer fees.
- (4) The deadline for payment of membership fees shall be the day before the beginning of the fiscal year as stipulated in Article 17.
- (5) New members will be exempt from paying membership fees at the time of admission.
- (6) For Associate Members, payment of admission fee in foreign currency may be made

in cash or by electronic payment via PayPal.

(7) Membership fees once paid will not be refunded. However, in the case of withdrawal due to death between the date of payment and the first day of the year to which the membership fee applies, the membership fee for that year will be refunded.

# Bylaw 13 Reappointment of Directors: Newly stipulated Bylaw

The handling of reappointment of Directors as stipulated in Article 11 shall be as follows: (1) Those who hold the positions of President, Vice-President, Treasurer and Auditor elected at the General Meeting pursuant to Article 10(1) and who have served two terms (four years) on the scheduled date of inauguration shall not be able to run for the same

positions.

(2) In the case where no candidate is present for a position under above (1), but an applicant is present during the candidate selection process at the Board of Directors Meeting, a person who has served two terms (four years) as of the scheduled date of inauguration shall not be a candidate. This does not apply if no other applicant is present.

- (3) In the case of Reginal and Sectional Directors elected under Article 10 (2), if an applicant for office is present during the election process at the Board of Directors Meeting, a person who has served two terms (four years) as of the scheduled date of inauguration shall not be reappointed, unless there is no other applicant for office.
- (4) The term of office for the purposes of this Bylaw 13 shall commence from the date of the 25th General Meeting and thereafter from the date of each General Meeting.

In accordance with Bylaw 13 (1), my maximum term of office is until the General Meeting in 2028. I would like to do my best as President of KCJ.

# The 41st KCJ Top Band Contest Rules

Your Log Submission is Indispensable.

- 1. Name of Contest: The 41st KCJ Top Band Contest.
- 2. Period: Starts 1200 UTC February 8, 2025. Ends 1200 UTC February 9, 2025.
- 3. Categories and codes:

C18: Single Operator

CP: Single Operator QRP

CM: Multi Operator

DX: Station overseas

SWL: SWL

CL: Check Log

Any kind of assistance for station operations for a category of Single Operator is prohibited. However, you may use "QSO finding assistance" such as, but not limited to, DX cluster, CW skimmer, Reverse Beacon Network and so on.

A QRP station must run the output power of five (5) watts or lower.

4. Frequency: 160-Meter

Please follow your band plan.

JA stations: 1801 -1820kHz

1820 -1825kHz: JA stations are able to respond running DX stations.

- 5. Mode: CW.
- 6. Exchange:

JA: RST plus Prefecture/district code (e.g., 599 TK)

DX: RST plus CQ Zone number (e.g., 599 03)

7. **Point**: All logs will be collated with each other and each complete contact counts points as follows.

For JA: one (1) point for a contact with JA, two (2) points with DX

For DX: two (2) points for a contact with JA, one (1) point with others.

When logs of other stations you contacted are not submitted, those contacts do not count points. Therefore, YOUR LOG SUBMISSION IS INDISPENSABLE.

8. Multipliers For JA: Each prefecture/district and CQ Zone worked

For DX: Each prefecture/district in JA worked

QSO data are cross-checked each other and coincidence QSO counts points.

- 9. **Scoring**: Multiplying total points by total multipliers
- 10. Log instructions:

Cabrillo file format or JARL file format are recommended.

- a. Each entry must be accompanied by summary sheet showing all scoring information, name and street-address of a participant.
- b. A QSO data should contain date, time, band, call sign and exchanges both sent and received.
- c. JA must log the time of QSO in JST and DX in UTC.
- d. Output power must be described in the log of category QRP.
- e. Names of all operators must be described in the log of the category Multi Operator.

#### 11. Log submission

- a. Web upload of logs is available at https://www.kcj-cw.com/contest/?DX
- b. Logs in Cabrillo format may be submitted directly to the following e-mail address: 2025toptest(a)kcj-cw.com (a) must be replaced with @.

- c. Paper logs may be mailed to

- 12. Log Deadline: 1500 UTC February 24, 2025

### 13. Releasing Results:

Results will be emailed twice to stations that provide their email addresses and submit logs.

The First Email: The preliminary results will be sent in early March.

The Second Email: The official results will be sent at the middle of March. Simultaneously, we will announce the official results on the KCJ Website.

Please access the URL on the above second email for the official results, a certificate (winners only), a participation certificate and an award KCJCA.

If you do not receive the email by March 31, please contact us at the contact address below.

14. **Awards**: Certificates will be awarded to several high rank entrants and the top in each prefecture/district for JA and the top of each entity.

The number of the stations to be awarded depends on the number of participants. Awards for SWL follow the same policy.

- 15. **The Certificate of Participation**: KCJ proves the participation of entrants in KCJ Contest with this certificate in which your call sign, name, score and rank appear.
- 16. **KCJCA**: KCJ issues the award KCJCA (Keymen's Club of Japan Contest Award) for the achievement of working many Japanese prefectures/districts.

#### 17. Prohibition:

Two or more simultaneous signals for a single operator

Two or more operation positions for multi operator

Two or more signals on a band for multi operator

18. **Disqualification:** Participants are expected to follow laws of each country and the KCJ Contest rules. KCJ contest committee makes the final decision to disqualify

a violator.

19. **Appeal**: If you have any objections to the provisional rankings, please email us with your concrete evidence to 41top-qstn(a)kcj-cw.com within 5 days of the release announcement.(replace (a) with @)
